As approved by the Regents in July 2018, Tuition was reduced to reflect the elimination of the temporary \$60 surcharge built into Tuition to cover costs associated with the judgments of the Kashmiri and Luquetta lawsuits, effective Fall 2018.

[1] All new Undergraduate, Graduate Academic, and Graduate Professional students admitted for the 2018-19 academic year will be charged a one-time, life-time document fee of \$150.00. Graduate students in the strictly professional degrees (M.D., J.D., D.V.M. and M.B.A.) are excluded and will continue with Pay-per-service charges. If students have comparable insurance and do not want to be enrolled in UC SHIP, they must apply for a UC SHIP waiver by the date specified for their school. [3] A quarterly (Fall, Winter and Spring) fee of \$86 will be charged to students who hold a F-1 or J-1 visa, excluding UC Education Abroad and non-UC Davis sponsored students (i.e. Fulbright or Vietnam Education Fund).
